Wall-Mart was asked to donate the clipboards; they needed the tax ID number so the forms were sent out a couple days ago. Hopefully we will here back from them soon.
Jim Harris team award was passed around. Very Touching! This will be awarded at the Rodeo.
Suggestion was made that a list of accomplishments be put on the back so years down the road they will not be forgotten. All were in favor.
Lebanon still needs to confirm on transits.
There is limited parking at the rodeo site around the perimeter. 20 cars at the bank, 40-50 at the pawn shop overflow, bus parking behind the store. L.D's service techs will make no parking signs and have traffic directors.
Marty Hopper found a good price on trophies; he will pick those up and be reimbursed by Western Bus.
Sweet Home SD will bring doughnuts and coffee.
Albany SD will be providing a bar-b-que. Judges will eat for free, any one else is \$5.00. They are serving: Hot dogs, hamburgers, chips, cookies and a soda.

Winter Workshop: Guest speakers: Deborah Lincoln and Claudia Howells came to discuss next years Winter Workshop. February 21, 2009 – proposed topic, Train vs. School Bus
Claudia Howells –from Operation Lifesaver started with some things she wanted us to think about, and concerns she has.

- Is this going to be possible? We will need to connect with safety groups from OR and State. The last OR train collision on file was in 1976. A report was made recently that a bus went around a gates in the Willamette Valley just a couple of weeks ago. This was reported by the train engineer.
- 2 years ago operation lifesaver sent out a safety module they made. There has been mixed feedback from it. It includes a 15 min. video and a worksheet. Since the turnover of drivers is so high it is very important that this is included in training. If anyone would like this training program, let her know its good material. Several trainers already use them.
- A training program is available for people within the organization. They will be certified to teach Railroad safety in the area at drivers meetings.
- Board of directors needs people – if interested contact Claudia.
- Operation Lifesaver has a trailer with lots of safety information. It's too late to get it for May 3rd but will look into bringing to Redmond May 31st for State Rodeo.
- ODE website will put a link in to Operation Lifesaver.

Winter Workshop: Possibilities of how it could work - Claudia

1. Stage the crash. Taking into account the uncontrollable.
 - Speed = impact = risk
 - Find a willing RXR; possibly Lebanon old mill industry site.
 - Insurance – liability
2. Mock Crash
 - Safer for RxR and spectators
 - Have a volunteer film the action
 - Bring in drama clubs for victims
 - Police dept and EMS

Chris Ellison comments

We would like to have the train actually hit a bus in the tail end containment area. This is to remind drivers they need to stop 15-50 feet from the tracks, always keeping the tail 15 feet off the tracks. Drivers get complacent and need to be reminded of the importance of this. Our area has many railroad crossings.

Deborah Lincoln comments

It would be a good opportunity for immediate training. It would also show how the chain of command works. Incident commander – DMV would be involved. In Ohio, 1973 a bus was hit by a train going backwards 4 miles an hour. It knocks the bus over pushing it down the tracks, when the train finally stopped there were a lot of fatalities and injuries. So speed is not necessary.

Discussion continued of ways we could keep safe yet have the audience feel the impact of this terrible scenario.

- ✓ Put audience in busses to watch from a distance
- ✓ Use an auditorium, watch from live feed
- ✓ Remote controlled train? Not available
- ✓ Lebanon to Foster line a possibility can use the River Center for Workshop good location. Rick Franklin owns this line and has clean up equipment.
- ✓ A low speed impact possibly backwards, has a box car hit the bus so there would be no damage to an engine.
- ✓ Place old video equipment on the bus and train to film the impact from all angles.
- ✓ Involve T.V. private organization for donations.
- ✓ Use a second bus for drama reenactment of crash scene.
- ✓ Agencies may not want to work Saturdays. This is the best day for the Schools
